RESPOND has been working to end domestic violence and homelessness in our communities for nearly 50 years. By joining our team as a Domestic Violence Counselor in our Law Enforcement Partnership Program (LEP), you will be partnering with local law enforcement and helping folks experiencing domestic violence find safety and life free of abuse. RESPOND's three tenets focus on our life changing work, our diverse team, and our commitment to learning.

#### The Domestic Violence Counselor's **Work**:

Each day will be different as you work in fast-paced police stations and courts, helping people in crisis find immediate solutions for a pathway to a life free of domestic abuse. Your day may include:

- Work with domestic violence survivors in a 1:1 setting providing crisis intervention, counseling, and a plan for immediate and long-term safety
- Provide follow-up and offer services to all victims of domestic violence named in police reports
- Accompany survivors to court, provide support with the process of clients obtaining restraining orders, and emotional support
- Actively participate in multidisciplinary teams inclusive of local law enforcement, district attorneys' office, and other criminal justice entities in an effort to collaborate on high-risk situations
- Helping a teammate out! Support a colleague or program in need of an extra set of hands

## The **team** you will be working with:

- Local law enforcement and criminal justice professionals creating a cutting-edge partnership
- A wide variety of community members, local schools, and diverse programs
- Staff who are committed to social services, social justice and the belief that housing and safety are human and fundamental rights
- Experts in diverse fields including domestic violence, criminal justice, early education, social work, business and accounting
- People who work hard and play hard! This work is tough; we bring our A-game every day.

# What you will **learn**, model or teach:

- How various partners can work together to keep survivors safe and offenders accountable in the communities served
- Trauma informed services are the cornerstone of RESPOND services. Program participants are treated with dignity and respect.

- Extensive training—RESPOND will provide at least 25 hours of domestic violence related training in the orientation period, and on-going training and continuous professional development opportunities
- Upward mobility—if you are looking for a career and not just a job, you are in the right place!

## Your Knowledge, Skills and Attributes:

- At least one year of case management, civilian advocacy or relevant experience working with individuals and families.
- Ability to work in loud, high stress environments with people who have experienced domestic violence
- Desire to provide domestic violence counseling while embedded in local police department
- Access to a personal vehicle, possession of a valid driver's license, and a willingness to transport
  program participants in RESPOND's service area. This position will travel daily.
- Practice cultural sensitivity and ability to relate to persons of diverse backgrounds, such as the LGBQ/T community and individuals with histories of substance abuse and/or mental health and different ethnic and social backgrounds.
- Bachelor's degree or High School Diploma/HISET or GED with 4 years' equivalent work experience strongly preferred.
- Must have or be willing to obtain the 25-hr Domestic Violence Training Certification and CJIS.

## RESPOND Compensation and Benefits include:
